

FDRP Resolution #06, from October 6th, 2015.

*This resolution contemplates additional procedures at the Law School of Ribeirão Preto for the revalidation of undergraduate degrees issued by foreign higher education institutions.*

The Dean of the Law School of Ribeirão Preto, in his legal duties, considering the CoG #7072 Resolution, from June 6<sup>th</sup>, 2015, the Undergraduate Committee's decision from September 27<sup>th</sup>, 2015, as well as the Faculty Senate's decision from October 2<sup>nd</sup>, 2015, issues the following

**RESOLUTION:**

**Article 1** – In order to revalidate an undergraduate law degree from foreign higher education institutions, the total workload and program curriculum of the candidate's degree will be compared to those offered at FDRP, taking both mandatory and elective courses into account.

**Sole Paragraph** – The Undergraduate Committee will not accept revalidation requests if the candidate's program's total workload is lower than 70% (seventy percent) of FDRP's workload.

**Article 2** – For every request approved by the Undergraduate Committee, the candidate will be requested to take an exam in up to 60 (sixty) days from the date they are notified of their request's approval. This is stipulated by Article 8 of the CoG #7072 Resolution, from June 26<sup>th</sup>, 2015.

**§1** – The exams will encompass general and open-ended questions regarding Law Theory, Public Law and Private Law, and it will be made sure the candidate is granted a minimum of thirty days to prepare.

**§2** – The grading criteria stipulated by the Undergraduate Committee will consider the candidate's mastery of Brazilian law, their ability to comprehend the foundations and sources of the national legal framework and their knowledge of native legal language.

**§3** – Unjustified absence at the date and time of the exam, scheduled by the Undergraduate Committee, is considered equivalent to withdrawing from the process.

**§4** – The exam will last for four hours and candidates are allowed to refer to legal text.

**§5** – After the exam is marked, the Undergraduate Committee will assign a rapporteur who will issue a final report, to be analyzed by the Committee at their following regular meeting.

**Article 3** – After the Undergraduate Committee finalizes their evaluation, their comprehensive report will be submitted to the Faculty Senate and to the Undergraduate Council next, in order for it to be properly certified.

**Article 4** – The Undergraduate Committee must check the titles from Institutions with which USP has Double Diploma Agreements. In this case, the degree will be automatically revalidated, given that the agreement was valid at the time of the student's graduation.

**Article 5** - Omission situations will be resolved by the Undergraduate Committee.

**Article 6** – This resolution will come into effect on its publishing date.
